Risks and dangers may arise from foreseeable or unforeseeable causes including, but not limited to, guide decision making, including a guide that may misjudge terrain, weather, trail or river route location, water levels, risks of falling out of or drowning while in a raft, canoe, kayak and such other risks, hazards and dangers that are integral to recreational activities that take place in the wilderness, outdoor or recreational environment; and (d) by my participation in the activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by negligence or other conduct of the owners, agents, officers, or employees of Moxie Outdoor Adventures, Wilderness Plus & North American Whitewater or by any other person.
